## GENERAL RENTAL CONDITIONS

### ON-SITE ACCOMMODATION

The campsite accepts rentals according to the dates and possibilities in order to guarantee its customers a rental for the day of their arrival. These are subject to certain conditions:

Any booking voucher will be accompanied by a check for 30% of the total cost of the stay and administration fees.

The check must be made out in the name of "LE TENZOR DE LA BAIE" or in Chèques Vacances.

### WEEKLY PRICES BELOW

The tourist tax is €0.46 per night and per person over 18 years old. The deposit includes 30% of the reservation and 15 € administration fees. The balance of the stay will be paid 15 days before your arrival by credit card.

A deposit of 450 € will be requested by bank imprint.

All "COMFORT PLUS" models (2 bedrooms) are equipped with roller shutters and mosquito nets on the bedroom windows, crockery for 4 or 6 people, electric coffee maker, extractor hood, fridge-freezer, dishwasher, TV, housework. Pet not allowed

We will endeavor to respect your choice, depending on availability, on the date of receipt of this contract.

Holiday residence for 1 - 4 people (depending on model), baby included

We offer optional Cancellation and Interruption insurance, covering in the event of Covid or contact, in your rental contract. For an amount of 4.5% of the total cost of your stay, our partner Gritchen Affinity will contact you a few days after the validation of this reservation.

Only one vehicle will be authorized per rental mobile home, the outdoor car park is at your disposal.

Plugging your electric vehicle into the mobile home is not permitted.

Any damage, incorrect cleaning or breakage will be invoiced and taken from the bank imprint.

You must advise us of any possible delay in your arrival, in order to keep your reservation. The manager reserves the right to dispose of the planned rental if there is no news 24 hours after the planned date of arrival.

Your rental is equipped with a shower and toilet. The sanitary facilities of the campsite are reserved for "campers", with the exception of the laundry. Your animal is tolerated in the rental, except in the "COMFORT PLUS". However, he must be kept on a leash (and muzzled depending on the race) on the campsite, never leave him alone in the mobile home. An up-to-date vaccination record is mandatory. Any damage caused by the animal will be your responsibility.

Early arrival and/or late departure (except July and August) will be subject to a request and charged at €15/hour.

The hour started will be charged in full.

Your visitors must report to reception and pay the entrance fee (€5.00 / person and  $\frac{1}{2}$  day, they must leave the campsite before 10 p.m.). They do not have access to the swimming pool. People who do not respect these conditions, as well as the internal rules of the campsite, will be expelled immediately.

Access to WIFI is payable by credit card from your accommodation.

For your comfort in your mobile home, don't forget:

Dish soap, soil, toilet paper, tea towels, sponge. Dishwasher products (Comfort Plus model), complete bedding sets.

"In the event of a dispute and after having contacted the establishment's "customer" service, any customer of the campsite has the possibility of contacting a consumer mediator, within a maximum period of one year from the date of the complaint. written, by with acknowledgment of receipt, to the operator.
